Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2020 to 2021 academic year.

Pupil premium funding enabled us to ensure that those pupils who required counselling were able to access this including during the lockdowns. Regular sessions and phone calls were made to check on pupil's wellbeing and provide valuable support.

Pupils were able to access extra-curricular clubs and music lessons that they may not have otherwise been able to access.

Pupils were provided with a healthy snack so as to ensure that they were provided with the right nutrients throughout the school day to help them with their learning.

Pupils received academic support in class, as part of interventions and tuition sessions to help them overcome gaps in their learning including gaps created due to the pandemic.
